GENERAL CONDITIONS & RULES

- 1. If admitted I promise to abide by the Rules & Regulation of the college and maintain the decorum, decency and discipline throughout my stay at all times both inside & outside the college.
- 2. I shall pay the prescribed fees and understand that fees once paid by me is not refundable under any circumstances.
- 3. I shall attend all the lectures, practical classes and test regularly and will complete all assignments in time as expected and demanded from me by the authorities. If I am short of attendance as per University rules, I fully understand that I will not be allowed to appear in annual Examination.
- 4. I fully understand that in event of any incidents warranting my explanation the decision of the management is final and totally binding on me.
- 5. I understand that my admission is initially on provisional basis. I shall produce all the necessary certificates as required by the university well in time for early confirmation of my admission.
- 6. I will fill & submit Reg./Re Reg. form with fee (before starting semester classes) in the month of June and Dec. of every year.
- 7. I shall not indulge in any strikes and unwanted activities.
- 8. I shall not distribute pamphlets (or) any other printed material without the permission of the concerned authority.
- 9. I shall always carry Identity Card. It should be produced as and when demanded.
- 10. I shall not cause any damage to the university property.
- 11. I shall come in prescribed uniform.
- 12. I understand that the university has right to add/delete/change the syllabus/course structure, rules & regulations as and when required.
- 13. In all disputes regarding the course, the decision of the vice chancellor/registrar of institute will be final & binding.
- 14. All legal matters or litigations will be settled in the court of Ranchi.
- 15. Students information is displayed on the notice board students are advised to go though the information board carefully in their own interest.
